Municipal Audit Director Dennis F. Dycus Receives National Leadership Award

The Association of Government Accountants (AGA) has presented Dennis F.

Dycus, the director of the Comptroller's Division of Municipal Audit, with its most prestigious award for a state government official.

Dycus was presented the 2012 William R. Snodgrass Distinguished Leadership Award today at the AGA's National Leadership Conference in Washington, D.C. The award is presented to state government officials who embody the highest personal and professional standards within the field of financial management.

This is the second consecutive year an official from the Tennessee Comptroller's office has won the award. Richard V. Norment, Assistant to the Comptroller

for the Department of Audit, received the award last year.

Dycus plans to retire at the end of June, capping a 39-year career with state government. His division is responsible for audits of city governments and other entities such as city schools, municipal utility districts, housing authorities, quasi-governmental agencies and nonprofit organizations that receive funds intended for public purposes. Dycus is a member of numerous local and national organizations that deal with accounting, fraud investigating and finances. He is past president of the Nashville chapter of the Association of Government Accountants and president emeritus of the Middle Tennessee chapter of Certified Fraud Examiners. He has been a regular speaker at TGFOA conferences, always entertaining and informative in his presentations.

"Dennis is very deserving of this recognition," Comptroller Justin P. Wilson said. "It serves as a great capstone to his career in state government. Without people like Dennis, there would be a great deal more fraud, waste and corruption in government. He and other auditors do work that some might find tedious in order to protect taxpayers' interests. I'm particularly proud that the AGA has chosen to honor someone from this office with such an important national award for the second year in a row."

GFOA Submits Comments to SEC on Proposed GASB Fee

The GFOA submitted comments on January 30 to the SEC in response to a Financial Industry Regulatory Authority (FINRA) proposal to establish a new Governmental Accounting Standards Board (GASB) Accounting Support Fee. FINRA's authority to issue the new fee is found in the *Dodd Frank Wall Street Reform and Consumer, Protection Act (P.L. 111-203)* and was included to ensure a stable funding source for the GASB. FINRA rules

must be approved by the SEC.

The proposed rule would assess a fee on FINRA member firms (financial institutions), using a formula based on secondary market municipal bond trading. The *Dodd Frank Act* requires the fee be paid by FINRA members. However, FINRA's proposal states that FINRA members may pass the fee onto its customers. This is of great concern to states and local govern-

ments. In previous comments to FINRA, as well as in its comment letter to the SEC, GFOA calls on FINRA to specifically state in its proposed rule that member firms can not pass the fee along to issuers of municipal securities. Without this statement, the proposed rule does not mirror the intent of the *Dodd Frank Act*, and would potentially create an unfunded mandate on states and local governments.

Six Best Practices Adopted by Executive Board

In January, the GFOA's Executive Board approved two new Best Practices (BPs) and four revised Best Practices. The Best Practices were sent to the Executive Board from the GFOA's Standing Committees. Below is a summary of the BPs, which may be read in full on the GFOA's web site.

In an effort to provide guidance on how governments will meet their programs and services objectives, the new BP Presentation of the Departmental Section in Operating **Budget Document recommends** that governments consider guidelines when presenting information in the departmental section of the operating budget document. A well-designed departmental section can enhance a reader's understanding of the purpose of funded programs or services, as well as the cost, creating a more effective operational and communications budget document.

The new BP Establishing and Administering and OPEB Trust recommends that governments create a

qualified trust to prefund their OPEB obligations. The best practice discusses the measures governments should take to properly establish and administrate a trust, including consulting with qualified legal counsel in order to fully understand the many issues involved.

The issue of government's social, economic and environmental sustainability efforts is reflected in the revised BP, The Public Finance Officers Role in Sustainability. The BP recommends that finance officers take an active role in their governments' efforts to think and act sustainably. This BP offers best practice tasks the finance officer can undertake to support sustainability.

A BP highlighting appropriate underwriter expenses charged to issuers called Expenses Charged by Underwriters in Negotiated Sales has been updated to clearly identify areas in which an issuer should have an agreement with the underwriter for various direct and

indirect expenses that are charged during a bond sale. The BP also states that <u>issuers should neither</u> pay the new GASB fee that will be <u>assessed on dealer firms</u> nor other MSRB and industry fees that are to be paid solely by the underwriter.

Understanding the ongoing responsibilities related to direct subsidy bonds has been addressed in a revised BP, Managing Build America and other Direct Subsidy Bonds. The BP serves to provide guidance to our members about the post sale responsibilities, including IRS requirements, and ensuring that subsidy payments arrive in-full and on-time.

The updated Best Practice <u>Using</u> <u>Mutual Funds for Cash Management Purposes</u> urges members to develop internal policies when investing in mutual funds. The BP highlights the types of mutual funds that are appropriate for short term and intermediate term investing and reminds governments to be vigilant about reviewing their specific holdings.

State & Local News

President Releases Fiscal Year 13 Budget Proposal

On Monday, February 13, President Obama sent to Congress a \$3.8 trillion budget proposal for FY 13 - a combination of revenue raisers and spending cuts, intended to shrink the projected 2012 deficit of \$1.33 trillion to \$704 billion by 2022. Almost \$850 billion in revenue would be raised by allowing the 2001 and 2003 tax cuts to expire at the end of this year for individuals earning more than \$250,000 annually. An additional \$580 billion in new revenue would be raised by reducing the value of tax breaks for high income earners. This proposal would limit current tax deductions and exemptions, including the state and local tax deduction and, for the first time, exemption of interest on tax-exempt municipal securities, for individuals with an adjusted gross income of more than \$200,000, or married couples with a combined adjusted gross income of more than \$250,000. GFOA has consistently opposed any limitations on these provisions in the tax code because of their potential costs to state and local governments.

With regards to spending initiatives as well as spending cuts, the budget includes \$350 billion to help jump start job creation, and include such proposals as extending the payroll tax cut and unemployment insurance benefits for the rest of 2012, \$30 billion to modernize 35,000 schools and \$30 billion to help states and localities retain and hire teachers and first responders. Also in the area of education, the budget proposes \$850 million for Race to the Top, which implements education re-

forms in several areas. It also offers a new \$5 billion competitive program to encourage states and school districts to work with their teachers and unions to attract and prepare new teachers.

In the area of environmental protection, the budget proposal provides \$125.4 million for Brownfield remediation activities and redevelopment. At the same time, it reduces funding for the Drinking Water and Clean Water State Revolving Funds from \$2.38 billion in FY 12 to \$2.03 billion in FY 13.

At the Department of Health and Human Services, the proposed budget cuts funding for the Low Income Energy Assistance Program (LIHEAP) from \$3.47 billion in FY 12 to \$3.02 billion in FY13. Funding for the Community Services Block Grant, which is used by states and localities for poverty reduction programs, is also significantly reduced, from \$679 million in the current fiscal year to \$350 million in FY 13.

In the areas of housing and community development, the budget preserves funding for the Community Development Block Grant and the HOME programs at 2012 levels, \$2.9 billion and \$1 billion respectively. It also provides \$34.8 billion to preserve rental housing assistance to millions of low-income families and \$154 million to expand the supply of affordable housing to seniors and persons with disabilities.

At the Justice Department, the budget requests \$257 million be allocated to the Community Oriented Policing Ser-

vices Program (COPS), an increase of \$90 million from the current fiscal year. The budget also includes \$4 million in immediate assistance for the retention and hiring of police officers, with a particular focus on the recruitment of post 9/11 veterans. However, funding is cut significantly for the State Criminal Alien Assistance Program, which reimburses states and localities for the costs of incarcerating undocumented immigrants, from \$240 million for the current fiscal year to \$70 million for FY 2013.

In the area of transportation, the budget proposal includes a six-year, \$476 billon surface transportation reauthorization bill, to create jobs and modernize the country's infrastructure. The transportation reauthorization proposal is paid for through current user finance mechanisms as well as part of the savings from ending the war in Iraq and winding down operations in Afghanistan. The budget adopts a "Fix-It-First" approach for highway and transit grants, which will emphasize improving the condition of existing infrastructure. It also consolidates 55 highway projects into five. The proposal also invests \$30 billion in a National Infrastructure Bank to provide loan and grants for projects of regional and national importance.

Finally, the President's plan proposes \$364 in savings from Medicaid and Medicare mostly affecting insurance companies and drug manufacturers.

New Guidance for Reporting Health Care Coverage on Form W-2

The Patient Protection and Affordable Care Act (Public Law No. 111-148) established new reporting requirements for the reporting of employer-provided health care coverage on Form W-

2. The IRS has released Notice 2012-9 (http://www.irs.gov/pub/irs-drop/n-12-09.pdf), which updates and clarifies information about these requirements, which apply to state and local govern-

ment entities and begin with Forms W-2 provided for the calendar year 2012.
